

How To Make a Counter Sign of the Important Notice & MP List

- 1. Print the "Important Notice" & "MP List"
- 2. Laminate the 2 pages the thicker the laminate the better, 150mic preferably. Print on card if thick laminate unavailable. This is to ensure the sheets stand upright.
- 3. Stick the two together with double sided tape at the top both pages reading outwards.
- 4. Stand it upright by spreading the sheets apart at the bottom.
- 5. Store bulk cards between the sheets and a pile of postcards for the customers to help themselves to in front of sign.

Please refer to diagram below;



Displaying this sign will help to make the postcards more visible when on a counter. We have found it to be most effective.
